Acceptance of Financial Responsibility

I, the parent/guardian of the registrant, a minor, agree to and understand that the **registration fee** is due at the time of registration. **Club fees** may be paid in full anytime or on the following schedule: **U8-U10 Players** (\$100 due August 15th, \$75 due January 1st), **U11-U12 Players** (\$175 due August 15th, \$150 due January 1st), **U13-14 Players** (\$175 due August 15th, \$200 due January 1st), **U15-U19 Players** (\$175 due November 1st, \$200 due January 1st). Players registering after January 1st, must pay 100% of their **club fees** within 30 days. Fees will not be prorated for players that register late. Registration/tryout fees are not refundable. Once a player is placed on a roster, they are expected to pay club fees for the year. No refunds should be expected unless the request is accompanied by a physician's letter stating the registrant is not fit to participate or if the player moves more than 75 miles outside the Rapid City area. Club fees include the following: training by the club DOC and/or age group coach, field maintenance, and insurance. They also include registration for Rushmore Cup, Winter Classic, and Presidents Cup tournaments.
